APPLICATION GUIDELINES AND GENERAL RULES:

- **Submitted recipes must be significantly different than previously submitted recipes.**
- The contest is open to all US residents of any age. Those applicants under the age of 18 must attach a letter of consent from their legal guardian to their application upon entry. Professional chefs, cooks, food stylists and other food specialists are prohibited from entering this contest.
- EE Bond prizes will be awarded for 1st, 2nd, 3rd place; \$100 EE Bond, \$75 EE Bond, \$50 EE Bond
- Food judges will have no interaction with contestants at time of tasting.
- Deadline for entry in the contest is May 30th, 2012 at 5:00 p.m. No exceptions will be made.
- Each recipe must contain a "notable" amount of horseradish root.
- Entries may be served either hot or cold and can range in complexity from a condiment to an entrée.
- All entries will be prepared in advance and brought to site for judging.
- The entrees will be judged on taste and appearance.
- Each contestant must provide 10 servings (at least 4 oz. each) for judging.
- By entering the contest, contestants attest that, to the best of their knowledge, recipes are original and unpublished. Contestants agree that their recipes will not be returned and become the property of the International Horseradish Festival (IHF), who reserves the right to edit, adapt, copyright, publish and use any or all of the recipes, including publishing on the internet, without additional compensation. Contestant agrees to execute any documents requested by the IHF to vest ownership of such rights in the IHF.
- Each recipe must be clearly printed on a separate sheet of white paper; this means all ingredients given in standard US measure and weight, complete directions for preparation, and any special utensils needed. This must also include the name, address and phone number of the applicant on the reverse side of the paper.
- The finalists agree to hold harmless the IHF, The Bank of Edwardsville, their related companies and agencies, their officers, directors, agents and employees from any liability arising out of participation in the contest and award or use of prizes.
- Contestants may enter as many recipes as they wish; however, only one prize will be given per contestant.
- Entries become the property of the IHF and cannot be returned. Acceptance of prize constitutes permission to use the winner's name, photo likeness, and recipe without compensation.
- This contest is void where prohibited by law and is subject to all federal, state and local laws and regulations.
- Contestants agree to be bound by these official rules and the decisions of the judges.
- IHF is not responsible for late, lost, misdirected, illegal or damaged entries.
