

## **ORDINANCE NUMBER 17-3**

### **AN ORDINANCE REGULATING WAGES OF LABORERS, MECHANICS AND OTHER WORKERS EMPLOYED IN ANY PUBLIC WORKS OR BY ANYONE UNDER CONTRACT FOR THE COLLINSVILLE AREA RECREATION DISTRICT, COLLINSVILLE, ILLINOIS**

**WHEREAS**, the State of Illinois has enacted the Prevailing Wage Act, “An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works”, approved June 26, 1941, as amended, being Chapter 820 ILCS 130/0.01-12, Illinois Compiled Statutes; and

**WHEREAS**, the aforesaid Act requires that during the month of June of each calendar year the Board of Commissioners of the Collinsville Area Recreation District investigate and ascertain the prevailing rate of wages, as defined in said Act for laborers, mechanics and other workers in the locality of said Collinsville Area Recreation District employed in performing construction of public works, for said Collinsville Area Recreation District; and

**NOW, THEREFORE, BE IT ORDAINED** by the President and Board of Park Commissioners of the Collinsville Area Recreation District, Madison and St. Clair Counties, Illinois, as follows:

#### **SECTION 1**

To the extent and as required by the Act, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the Collinsville Area Recreation District is hereby ascertained to be the same as the prevailing rate of wages for construction work in the Madison and St. Clair County areas as determined by the Department of Labor of the State of Illinois as of June 5, 2017, a copy of that determination being attached hereto as Exhibit “A” and incorporated herein by reference. As required by said Act, any and all revisions of the prevailing rate of wages by the Department shall supersede the Department’s June 5, 2017 determination and apply to any and all public works construction undertaken by the Park District. The definition of any terms appearing in this Ordinance that are also used in the Act shall be the same as in said Act.

#### **SECTION 2**

Nothing herein contained is intended to apply nor shall be construed to apply said prevailing rate of wages as herein ascertained to any work or employment performed on behalf of the Collinsville Area Recreation District except public works construction to the extent required by the aforesaid Act.

#### **SECTION 3**

The Board Secretary shall by June 30<sup>th</sup>, 2017, publicly post or keep available for inspection by any interested party in the main office of this Collinsville Area Recreation District this determination of such prevailing rate of wage.

**SECTION 4**

The Board Secretary shall by July 15, 2017, file a certified copy of this Ordinance with the Illinois Department of Labor.

**SECTION 5**

Within thirty (30) days after filing a certified copy of this Ordinance with the Illinois Department of labor, the Board Secretary shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**SECTION 6**

Within thirty (30) days after filing a certified copy of this Ordinance with the Illinois Department of Labor, the Board Secretary shall cause a notice to be published in a newspaper of general circulation within the area that the determination of prevailing wages has been made. Said notice shall conform substantially to the notice attached hereto. Such publication shall constitute notice that this is the determination of the Collinsville Area Recreation District and is effective.
