

ORDINANCE # 11- 5

**AN ORDINANCE FOR THE LEVY OF TAXES
FOR THE COLLINSVILLE AREA RECREATION DISTRICT FOR THE FISCAL
YEAR BEGINNING MAY 1, 2012 AND ENDING APRIL 30, 2013.**

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COLLINSVILLE AREA RECREATION DISTRICT, COUNTIES OF MADISON AND ST. CLAIR, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1. That the sum of one million three hundred sixteen thousand dollars and no cents (\$1,316,000.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of May, 2012 and ending the 30th day of April, 2013, by Collinsville Area Recreation District for all corporate purposes of said Park District and for purposes of providing for a Corporate and Recreational Program Fund, Liability Insurance Fund, Audit Expense Fund, Illinois Municipal Retirement Fund, Social Security Fund, Museum Fund, Paving and Lighting Fund, Special Recreation Fund and Workers Compensation Fund, be and the same is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal year. The specific amount as levied for the various purposes mentioned above are as set forth below, said taxes levied being for said current fiscal year of said District and for the said appropriations to be raised by taxation, the total of which have been ascertained as aforesaid, and being as follows:

SECTION 2. That the total amount of one million six hundred three hundred sixteen thousand dollars and no cents (\$1,316,000.00) ascertained as aforesaid, be and the same is hereby levied and assessed on all property subject to taxation within the Collinsville Area Recreation District according to the value of said property as the same is assessed and equalized for the State and County purposes for the current year.

SECTION 3. That there is hereby certified to the County Clerks of Madison and St. Clair Counties, Illinois, the several sums aforesaid constituting said total amount of one million three hundred sixteen thousand dollars and no cents (\$1,316,000.00) which said total amount the said Collinsville Area Recreation District requires to be raised by taxation for the current fiscal year of said Park District, and the Secretary of said District is hereby ordered and directed to file with the County Clerks of said Counties on or before the time required by law, a certified copy of this Ordinance.

SECTION 4. This Ordinance shall take effect and be in full force and effect immediately upon and after its passage and approval.



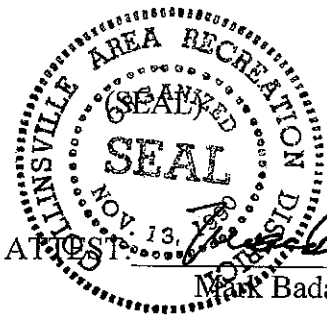


CERTIFICATE OF PRESIDING OFFICER
