AN ORDINANCE AMENDING ORDINANCE NUMBER 12st. CLAIR COUNTY CLERK FOR THE LEVY OF TAXES FOR THE COLLINSVILLE AREA RECREATION DISTRICT FOR THE FISCAL YEAR BEGINNING MAY 1, 2012 AND ENDING APRIL 30, 2013

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COLLINSVILLE AREA RECREATION DISTRICT, COUNTIES OF MADISON AND ST. CLAIR, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1. On December 20, 2011 the Board of Commissioners approved Ordinance 11-5 that levied and assessed on all property subject to taxation within the Collinsville Area Recreation District according to the value of said property as the same is assessed and equalized for the State and County purposes for the current year the sum of one million three hundred sixteen thousand dollars and no cents (\$1,316,000.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of May, 2012 and ending the 30th day of April, 2013, by Collinsville Area Recreation District for all corporate purposes of said Park District and for purposes of providing for a Corporate and Recreational Program Fund, Liability Insurance Fund, Audit Expense Fund, Illinois Municipal Retirement Fund, Social Security Fund, Museum Fund, Paving and Lighting Fund, Special Recreation Fund and Workers Compensation Fund. On January 17, 2012 Ordinance 12-2 was adopted by the Board of Commissioners to amend the specific amount as levied for these various funds and purposes.

SECTION 2. The specific amount as levied for the various funds and purposes mentioned above as set forth in Ordinance 11-5, and amended as set forth in Ordinance 12-1, are hereby amended as set forth below:

That there is hereby certified to the County Clerks of Madison and St. Clair Counties, Illinois, the several sums aforesaid, as amended from Ordinance 11-5 and Ordinance 12-1, constituting the same total amount of one million three hundred sixteen thousand dollars and no cents (\$1,316,000.00) as levied and approved in Ordinance 11-5 and as certified to the County Clerks of Madison and St. Clair County on or prior to the last Tuesday of December, 2011.

SECTION 5. The Secretary of said District is hereby ordered and directed to file with the County Clerks of said Counties on or before the time required by law, a certified copy of this Ordinance.

SECTION 6. This Ordinance shall take effect and be in full force and effect immediately upon and after its passage and approval.
