ORDINANCE # 12-8

AN ORDINANCE FOR THE LEVY OF TAXES FOR THE COLLINSVILLE AREA RECREATION DISTRICT FOR THE FISCAL YEAR BEGINNING MAY 1, 2013 AND ENDING APRIL 30, 2014.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE COLLINSVILLE AREA RECREATION DISTRICT, COUNTIES OF MADISON AND ST. CLAIR, STATE OF ILLINOIS, AS FOLLOWS:

SECTION 1. That the sum of one million three hundred thousand dollars and no cents (\$1,300,000.00) being the total of that part of the appropriations heretofore legally made which are to be raised by taxation for the current fiscal year beginning the 1st day of May, 2013 and ending the 30th day of April, 2014, by Collinsville Area Recreation District for all corporate purposes of said Park District and for purposes of providing for a Corporate and Recreational Program Fund, Liability Insurance Fund, Audit Expense Fund, Illinois Municipal Retirement Fund, Social Security Fund, Museum Fund, Paving and Lighting Fund, Special Recreation Fund and Workers Compensation Fund, be and the same is hereby levied upon all taxable property within said Park District subject to taxation for said fiscal year. The specific amount as levied for the various purposes mentioned above are as set forth below, said taxes levied being for said current fiscal year of said District and for the said appropriations to be raised by taxation, the total of which have been ascertained as aforesaid, and being as follows:
